Fuzion Bible Institute is a Christian educational ministry dedicated to providing theological education and ministry training to believers worldwide.

The Institute offers structured programs designed to equip students with biblical knowledge, ministry skills, and spiritual formation necessary for effective service within the Body of Christ.

Instruction is delivered primarily through online learning platforms, enabling students across the United States and internationally to participate in academic programs.

## PURPOSE OF THE INSTITUTION

Fuzion Bible Institute exists to provide Christ-centered theological education that prepares believers for ministry leadership, discipleship, evangelism, and service within churches and faith-based ministries.

The institution seeks to develop students academically, spiritually, and practically so they may effectively serve the Body of Christ.

# STATEMENT OF FAITH

**Fuzion Bible Institute** has been formed as a Christian educational ministry under the Lordship of Jesus Christ. Our supreme desire is to know Christ and be conformed to His image by the power of the Holy Spirit. We are a non-denominational, Spirit-filled ministry, yet we are not opposed to denominations as such, only to the over-emphasis of the doctrinal differences that have led to the division of the Body of Christ.

**The Holy Scripture** - We believe the Bible is the inspired, inerrant, infallible, irrevocable and complete Word of God and is therefore our supreme and final authority in all matters that it addresses. (*2 Tim. 3:16, 17*)

**The Eternal Godhead** - We believe that God is Triune, existing eternally and simultaneously as three distinct persons: Father, Son, and Holy Spirit. All three persons in the Godhead share equally and completely the one divine nature, and are therefore the same God, coequal in power, nature and glory. (*1 John 5:7*)

**Jesus Christ** - We believe that Jesus Christ, the second person of the Trinity, is God the Son who has neither beginning nor ending. He was conceived in the flesh by the Holy Spirit, born of the Virgin Mary, and is fully God and fully man. Jesus died for our sins, was buried, and arose bodily on the third day. He ascended into heaven and is now seated at the right hand of God the Father as our only mediator, high priest, and advocate. He will return in glory to resurrect and judge all mankind. (*Matthew 1:23-25/John 1:1/14:3/Acts 4:12/1 Corinthians 15:3-4 & 20/Philippians 2:5-11/ 1 Timothy 2:5-6/Hebrews 4:14-16/1 Peter 2:22.*)

**Holy Spirit** - We believe that the Holy Spirit is God, the third person of the Trinity who is coequal with the Father and Son. The Holy Spirit's ministries include: Convicting all people of sin; calling, bringing regenerating, indwelling, and baptizing believers into the Body of Christ; setting them apart to a holy life; and teaching, keeping, and empowering them day by day for godly living and spiritual service. The Holy Spirit distributes spiritual gifts to each believer according to His will. God in His sovereignty still works in miraculous ways. (*John 3:5-8/Acts 1:8/5:3-4/16:7-14/1 Corinthians 2:9-12/3:16/12:3-13 & 28-31/13:8-11/Galatians 5:16-25/Ephesians 1:13-14/5:18/Hebrews 2:3-4*)

**The Fall of Man** - We believe that man was created in the image and likeness of God to fellowship with Him and give Him glory. Adam and Eve through voluntary disobedience chose to rebel against God and as a result all of mankind became separated from God. The only remedy for this is redemption through faith in Jesus Christ. (*Rom. 5:12*)

**Basis of Salvation** - We believe that while we were yet sinners Christ died for us, signing the pardon of all who believe on Him and confess Jesus Christ as their Lord. We believe that Jesus Christ is the only way to salvation and that there is absolutely no other way to be reconciled back to God the Father. (*John 3:16; Rom. 5:8, Rom. 10:9-10; Acts 4:12*)

**Salvation through Grace** - We believe that before salvation we have no righteousness of our own and must come to God through the righteousness of Christ. (*Eph. 2:8*)

**Repentance and Acceptance** - We believe that upon sincere repentance and a wholehearted acceptance of Christ as Lord, we are justified before God. *(1 John 1:9)*

**The New Birth** - We believe that the change which takes place in the heart and life at conversion is a literal one and is the result of being born of the Spirit of God. *(2 Cor. 5:17; Gal. 2:20; John 3:5-7)*

**Daily Christian Life** - We believe that it is the will of God that we live a sanctified and holy life, growing constantly in the Faith. *(Heb. 6:1)*

**Water Baptism** - We believe that baptism by immersion in water is an outward sign of the inward work of salvation. *(Matt. 28:19)*

**The Lord's Supper** - We believe in the commemoration of the Lord's Supper by the symbolical use of the bread and the juice of the vine. *(1 Cor. 11:28)*

**Baptism of the Holy Spirit** - We believe that the Baptism of the Holy Spirit is to endow the believer with power, and that His empowering is after the same manner as in Bible days. *(Acts 1:8; 2:4)*

**The Spirit-Filled Life** - We believe that it is the will of God that we walk in the Spirit continually. *(Rom. 8:1-2; 14-16)*

**The Gifts and the Fruit of the Spirit** - We believe that the Holy Spirit has gifts to bestow upon the Christian and that we should show spiritual fruit as evidence of a Spirit-filled life. *(1 Cor. 12:1-11; Gal. 5:22-23; Rom. 12:6-8; Eph. 4:11-13)*

**Divine Healing** - We believe that divine healing is the provision of Christ to heal the sick in response to the exercise of faith, the prayer of faith, the prayer of agreement, anointing with oil, the gifts of healing or the laying on of hands. We believe that this provision of Christ is for everyone today. *(1 Peter 2:24; Matt. 8:17; 18:18-19; James 5:14-16; 1 Cor. 2:9; Mark 16:15-18; Matt. 24:35; Mark 13:31; Luke 21:33)*

**The Second Coming** - We believe that the Second Coming of Christ is literal and inevitable. *(1Thes. 4:16-17)*

**Church Fellowship** - We believe it is our sacred duty to identify and actively participate with the local and visible church of Christ. *(Acts 16:5; Heb. 10:25)*

**Civil Government** - We believe that the laws of the land should be upheld at all times except in matters opposed to the Word of God. *(Rom. 13:1-5)*

**The Final Judgment** - We believe that all shall stand one day before God in final judgment, and there receive eternal reward or eternal judgment. *(2 Cor. 5:10; Rev. 20:11-13)*

**Heaven** - We believe that heaven is a literal place, eternally existent. *(John 14:2; Rev. 7:15-17)*

**Hell** - We believe that hell is a literal place of eternal torment for all who reject the Lord Jesus Christ. (Rev. 20:10,15)

**Evangelism** - We believe that evangelism is the Great Commission given to the Church and as the church every believer is spiritually obligated in fulfilling this commission. (James 5:20; Mark 16:15; 2 Cor. 5:18-21)

**Tithes and Offerings** - We believe that the method ordained of God for the support and spread of His cause is by the giving of tithes and freewill offerings. (Mal. 3:10; 2 Cor. 9:7; Heb. 7:8)

**Worship** - We believe that “acceptable” and “true” worship is prescribed by God Himself in His Word. This embodies individual and corporate expressions of praise and thanksgiving and reverence in holiness. **We believe** worship of God should be spiritual. Therefore, we remain flexible and yielded to the leading of the Holy Spirit to direct our worship. (John 4:24; Psalm 150)

**Church Government** - We believe in church government to ensure order, and we believe in loyalty to those acting in rightful authority as they lead us in the Lord. (1 Peter 5:1-5; Rom. 13)

**Unity, Understanding and Love** - We believe that in essentials there must be unity, in nonessentials - understanding, and in all things - love. We believe the only true basis of Christian fellowship is Christ's Agape love, which is greater than any differences we possess and without which we have no right to claim ourselves Christians.

**Marriage, Gender and Sexuality** - Fuzion Ministries International and Fuzion Bible Institute fully embrace the teachings of the traditional biblical view with regard to the goodness of our sexuality, the importance of chastity and the place of heterosexual marriage as God's intended context for complete sexual expression to occur (Gen.2:21-24.)

Fuzion believes that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God. (Gen 1:26-27.)

Rejection of one's biological sex is a rejection of the image of God within that person.

We also believe that the term “marriage” has only one meaning: the uniting of one man and one woman in a single, exclusive union, as delineated in Scripture. (Gen 2:18-25.) We believe that God intends sexual intimacy to occur only between one man and one woman, who are married to each other. (1 Cor 6:18; 7:2-5; Heb 13:4.) We believe that God has commanded that no intimate sexual activity be engaged in outside of a marriage between one man and one woman.

Therefore, any form of sexual immorality, including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, and use of printed, videoed, or virtual pornography is sinful (Matt 15:18-20; 1 Corinthians 6:9-10.)

We define adultery as the turning of one's intimate affections to someone other than the spouse. Sometimes, but not always, these affections culminate in sexual activity. Fornication includes any form of sexual intercourse, oral sex or any physical contact producing sexual stimulation.

We believe that in order to preserve the function and integrity of Fuzion, and to provide a Biblical role model to the members of Fuzion and the community, it is imperative that all members of Fuzion, those employed by Fuzion in any capacity, or who serve as volunteers, agree to and abide by this Statement on Marriage, Gender, and Sexuality. (Matt 5:16; Phil 2:14-16; 1 Thess 5:22.)

We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ. (Acts 3:19-21; Rom 10:9-10; 1 Cor 6:9-11.)

We believe that **EVERY** person must be afforded compassion, love, kindness, respect, and dignity. (Mark 12:28-31; Luke 6:31.)

**Hateful and harassing behavior or attitudes directed toward any individual are to be REPUDIATED and are NOT in accord with Scripture nor the doctrines of Fuzion Ministries International, Fuzion Bible Institute or any subsidiary of the Fuzion Global Network.**

# INSTITUTIONAL STATUS

## Accreditation

### IS FUZION BIBLE INSTITUTE ACCREDITED?

FUZION BIBLE INSTITUTE is an Accredited Member of Transworld Accrediting Commission International. Serving the Christian educational community for over 30 years, Transworld has been a federally recognized, non-profit church educational organization. Their philosophy is to demonstrate accountability to the public for education obtained in nontraditional evangelical educational institutions.



### STATE OF FLORIDA DEPARTMENT OF EDUCATION

In the United States of America, jurisdiction over degree-granting institutions rests with the individual state governments. Compliance with state regulations is the necessary condition for offering a legitimate, legal American degree. Fuzion Bible Institute is compliance with Section 1005.06(1)(f), Florida Statutes. The state of Florida does not require regional or theological accreditation. Please Note: Fuzion Bible Institute as well as other Christian colleges are NOT required to be regulated by the Florida Department of Education (FLDOE); therefore, Fuzion Bible Institute is not listed with the FLDOE as a 'regulated' institution. Fuzion Bible Institute is in compliance with the statutes of the Florida State Board of Independent Colleges and Universities to offer legitimate, legal American degrees.

*Fuzion Bible Institute (FUZION) does not have a regional secular accreditation. If you desire to pursue a degree for secular employment, a degree with Fuzion Bible Institute may not be the right choice for you. FUZION does not guarantee a job or ordination in any specific market or ministry. Although WWAC accredits our degrees, FUZION is not listed at this time with a U.S. Department of Education-approved accreditation agency. A FUZION degree is NOT specifically suited for people pursuing secular jobs such as public school teachers, state university professors, and state-licensed counselors or psychologists, among other vocations requiring state licensure.*

### **Tax Exempt Non-Profit Status**

Fuzion Bible Institute is a non-profit corporation located in the state of Florida, USA. It is recognized as a tax exempt organization under Section 501(c)3 of the US Internal Revenue Code.

### **Relationship to State Licensure**

Programs offered by Fuzion Bible Institute are designed for religious and ministry purposes and are not intended to meet educational requirements for professional licensure regulated by the State of Florida.

## GRADUATION REQUIREMENTS

Students must complete all required coursework and maintain a minimum cumulative GPA of 2.0 to graduate.

## TRANSFER CREDIT POLICY

Transfer credit may be accepted from institutions when coursework is determined to be comparable in academic level and content.

The transferability of credits earned at this institution to another institution is solely at the discretion of the receiving institution.

## LIFE EXPERIENCE CREDIT

Students with significant ministry experience may apply for academic credit through documented life and ministry experience portfolios.

# TUITION AND FEES

Tuition is charged on a per-program basis and covers all courses within the designated academic period of study.

Program Tuition:

- Certificate Programs: \$1,200 per academic year
- Diploma Programs: \$1,200 per academic year
- Bachelor Programs: \$1,200 per academic year
- Master Programs: \$2,000 total program cost
- Doctoral Program: \$2,700 total program cost

Tuition includes digital course materials. Any additional administrative, application, or registration fees will be disclosed to the student prior to enrollment.

## STUDENT RIGHT TO CANCEL

A student has the right to cancel the enrollment agreement and receive a full refund of all tuition and fees paid if cancellation is made within three (3) working days after signing the enrollment agreement.

Cancellation must be submitted in writing to the Admissions Office or Registrar.

The effective date of cancellation shall be the date the written notice is received by the institution.

## DROP-ADD PERIOD POLICY

Students who withdraw from a course or program within the first week of classes (drop-add period) are entitled to a 100% refund of all tuition and fees paid.

No academic or financial penalty will be incurred during this period.

## REFUND POLICY

For students who withdraw after the drop-add period, refunds will be issued according to the following schedule:

- Withdrawal prior to the start of classes or during the drop-add period: 100% refund of all tuition and fees
- Withdrawal after the first class: 75% refund of tuition
- Withdrawal after the second class: 50% refund of tuition
- Withdrawal after the third class: No refund

Administrative, application, and registration fees may be non-refundable after the drop-add period, unless otherwise required by law.

Refunds are calculated based on the student's official withdrawal date, defined as the date written notice is received by the Registrar. Refunds will be processed within a reasonable period of time following the determination of the withdrawal date.

Refunds will be issued within thirty (30) days of the official withdrawal date.

## **FINANCIAL RESPONSIBILITY**

Students are responsible for all tuition and fees incurred up to the effective date of withdrawal.

Financial obligations may include:

- Tuition charges
- Administrative or registration fees
- Any applicable program-related costs

The institution reserves the right to withhold transcripts, certificates, diplomas, and academic records until all financial obligations have been satisfied.

## **LEAVE OF ABSENCE AND FINANCIAL IMPACT**

Students approved for a Leave of Absence (LOA) remain responsible for any outstanding financial obligations incurred prior to the leave.

No additional tuition charges will be applied during an approved LOA period unless the student resumes active coursework.

## **REINSTATEMENT AND OUTSTANDING BALANCES**

Students seeking reinstatement after withdrawal must:

- Submit a formal request for reinstatement
- Satisfy all outstanding financial obligations prior to re-enrollment

Reinstatement is subject to institutional approval.

## **FINANCIAL AID DISCLOSURE**

Fuzion Bible Institute does not participate in federal or state financial aid programs.

Students are responsible for funding their education through personal financial resources or other private means.

## **EMPLOYMENT PLACEMENT SERVICES POLICY**

Fuzion Bible Institute does not provide employment placement services. The institution does not guarantee employment, ministry placement, ordination, or salary outcomes upon completion of any program.

Students are solely responsible for securing employment or ministry opportunities. Any guidance, mentorship, or networking opportunities provided by the institution are informal and do not constitute a placement service.

## **STUDENT WITHDRAWAL, LEAVE OF ABSENCE, INACTIVITY, AND FINANCIAL RESPONSIBILITY POLICY**

### **1. Purpose**

This policy establishes the institutional standards and procedures governing student withdrawal, leave of absence, inactivity, administrative withdrawal, financial responsibility, and reinstatement

### **2. Student Withdrawal**

2.1 A student withdrawal is defined as the voluntary discontinuation of enrollment in a course or program prior to completion.

2.2 Students must submit a written notice of withdrawal to the Academic Office or Registrar.

2.3 The official withdrawal date shall be the date on which the written notification is received.

2.4 Non-attendance or failure to participate in academic activities does not constitute an official withdrawal.

### **3. Leave of Absence (LOA)**

3.1 A Leave of Absence (LOA) is defined as an approved temporary interruption of a student's course of study.

3.2 Students requesting an LOA must submit a written request stating the reason for the leave.

3.3 The institution may grant an LOA for a period not to exceed twelve (12) months.

3.4 Students who do not return within the approved LOA period may be required to reapply for admission and may be subject to current program requirements.

#### **4. Student Inactivity**

4.1 A student shall be deemed inactive upon failure to engage in required academic activities for a period of thirty (30) consecutive days, or the equivalent duration within modular or non-term programs.

4.2 Academic engagement includes, but is not limited to:

- Attendance in scheduled classes or training sessions
- Submission of assignments or coursework
- Participation in required academic or ministry-related activities
- Communication with instructors or academic staff regarding coursework

#### **5. Notification of Inactivity**

5.1 Upon determination of inactivity, the institution will make reasonable attempts to contact the student using available communication methods.

5.2 The student may be required to:

- Confirm intent to continue enrollment
- Submit outstanding academic work
- Request a Leave of Absence, if applicable

#### **6. Administrative Withdrawal**

6.1 The institution reserves the right to administratively withdraw a student under any of the following conditions:

- Prolonged inactivity or non-participation
- Failure to respond to institutional communications
- Failure to meet academic requirements
- Violation of institutional policies or codes of conduct
- Failure to satisfy financial obligations

6.2 For withdrawals due to inactivity, the effective withdrawal date shall be recorded as the last date of documented academic participation.

6.3 Administrative withdrawal does not relieve the student of financial responsibility for charges incurred prior to the withdrawal date.

## **7. Financial Responsibility**

7.1 Students are responsible for all tuition and fees incurred up to the effective date of withdrawal, Leave of Absence, or administrative withdrawal.

7.2 Financial obligations include, but are not limited to:

- Tuition charges assessed
- Program or course-related fees

7.3 The institution shall withhold transcripts, certificates, diplomas, and other academic records until all outstanding financial obligations have been satisfied.

7.4 Students returning from a Leave of Absence or seeking reinstatement must satisfy all outstanding balances prior to re-enrollment.

7.5 Any applicable refunds shall be processed in accordance with the institution's published Refund Policy.

## **8. Reinstatement**

8.1 Students who have been withdrawn may apply for reinstatement in accordance with institutional procedures.

8.2 Reinstatement is not guaranteed and is subject to institutional approval.

8.3 Approval may be contingent upon:

- The student's prior academic standing
- The length of time since withdrawal
- Satisfaction of all outstanding financial obligations

8.4 The institution reserves the right to require the student to repeat courses or restart portions of the program where academic requirements were not completed.

## **9. Hardship Consideration**

9.1 The institution may, at its sole discretion, consider requests for exceptions to this policy in cases of documented hardship, including but not limited to medical, financial, or personal circumstances.

9.2 Students seeking consideration must submit a written request with supporting documentation.

9.3 Approved accommodation may include:

- Adjusted payment arrangements
- Temporary financial accommodations
- Limited fee adjustments

9.4 All determinations under this section are made at the sole discretion of institutional leadership and are final.

## Maximum Time to Complete a Program

Students are expected to complete their program of study within a reasonable timeframe to ensure that their training reflects the most current curriculum and ministry preparation.

Unless otherwise approved by the administration, students must complete all program requirements within the following time limits:

Certificate	1 Year
Diploma	1 Year
Bachelor's Degree	1 Year
Master's degree	2 Years
Doctoral Degree	3 Years

The time limit begins from the **date of initial enrollment** in the program.

## Extension Requests

Students who are unable to complete their program within the established time limit may submit a written request for an extension to the Academic Office.

Extensions may be granted under special circumstances such as:

- Ministry assignments
- Health or family situations
- Approved Leaves of Absence

If an extension is granted, the institute may require the student to complete **updated coursework** to meet current curriculum requirements.

## Curriculum Updates

Students who exceed the maximum completion time or return after an extended absence may be required to:

- Follow the **current catalog requirements**, or
- Complete **additional or updated courses** to ensure their training meets current academic standards.

# STUDENT SERVICES

Students have access to faculty support, academic advising, and ministry mentoring during their studies.

## STUDENT CODE OF CONDUCT

Students are expected to demonstrate Christian character and integrity consistent with the teachings of Scripture.

The student must recognize this purpose and endeavor to exemplify an attitude of excellence and maintain the highest level of respect for the aim and purpose of the Institute.

## DISCIPLINARY PROCEDURES

The institution reserves the right to discipline, suspend, or dismiss students for academic dishonesty, misconduct, or violation of institutional policies.

## STUDENT COMPLAINT PROCEDURE

1. Students who have complaints should first attempt to resolve the issue with the instructor or department involved.
2. If unresolved, the complaint may be submitted in writing to the Registrar.
3. If necessary, the matter may be escalated to the President of the Institute for final review.

## APPEALS PROCEDURE

Students may appeal academic or disciplinary decisions by submitting a written appeal within fourteen days of the decision.

Appeals are reviewed by institutional leadership and decisions are final.

## RELATIONSHIP TO PROFESSIONAL LICENSURE

Programs offered by Fuzion Bible Institute are religious in nature and do not qualify graduates for state-licensed professions.

## STUDENT RECORDS AND TRANSCRIPTS

Official transcripts may be requested through the Registrar's Office. Transcript release may be withheld if financial obligations are outstanding.

## **CATALOG CHANGES**

Fuzion Bible Institute reserves the right to modify policies, procedures, tuition, and program offerings as necessary.

## **ACADEMIC CALENDAR**

Fall Term: September – December

Spring Term: January – April

Summer Term: May – August

Specific course start dates are announced by the Registrar prior to each term.

# FACULTY AND LEADERSHIP

## **President**

The President of Fuzion Bible Institute serves as the chief academic and administrative officer of the institution and is responsible for leadership, academic integrity, and the fulfillment of the institutional mission.

## **Academic Leadership**

The academic leadership team oversees curriculum development, faculty appointments, academic policies, and student academic progress.

## **Faculty**

Faculty members are selected based on their theological education, ministry experience, and commitment to Christian discipleship and academic excellence.

# COURSE DESCRIPTIONS

## **MIN101 – Ministry of the Holy Spirit**

This course explores the person, work, and ministry of the Holy Spirit in the life of the believer and the Church. Emphasis is placed on spiritual empowerment, gifts of the Spirit, guidance, and the role of the Holy Spirit in advancing the Kingdom of God.

## **BTH101 – Foundations of Faith**

This course establishes core biblical principles essential to the Christian life, including salvation, repentance, faith, baptism, and spiritual growth. Students will develop a strong foundation for personal faith and ministry practice.

## **THEO101 – Basic Christian Doctrine 1**

An introduction to essential Christian doctrines, including the nature of God, the authority of Scripture, and the person of Jesus Christ. This course provides a theological framework for understanding biblical truth.

## **THEO102 – Basic Christian Doctrine 2**

A continuation of Basic Christian Doctrine 1, focusing on the doctrines of salvation, the Church, the Holy Spirit, and end-times. Students will deepen their theological understanding and application of doctrine.

## **EVG101 – Discipleship Evangelism**

This course equips students with practical tools for evangelism and disciple-making. Emphasis is placed on personal evangelism, sharing the Gospel effectively, and establishing new believers in their faith.

## **BTH102 – Blood / Abrahamic Covenants**

This course examines the biblical concept of covenant, with a focus on the Abrahamic Covenant and the redemptive significance of the blood throughout Scripture. Students will gain insight into God's covenantal relationship with His people.

## **BTH103 – Biblical Worldview**

This course develops a biblical framework for understanding life, culture, and truth. Students will learn to evaluate contemporary issues through Scripture and apply a Kingdom perspective to everyday living.

## **MIN102 – Biblical Profile of Women**

This course explores the role, identity, and influence of women in Scripture. Through biblical examples, students will examine God's design, purpose, and calling for women in both ministry and society.

## **PRY101 – Knowing God’s Voice**

This course trains students to recognize and respond to the voice of God through Scripture, the Holy Spirit, and spiritual discernment. Emphasis is placed on developing sensitivity to God’s leading and growing in prophetic awareness.

## **LED101 – Vision & Values**

This course defines the mission, vision, and core values of the institute and the broader Kingdom mandate. Students will align with organizational DNA while developing personal vision and purpose for effective ministry.

## **LIF201–203 – Life Management 1–3**

This three-part course sequence equips students with practical principles for personal growth, discipline, and effective Christian living. Topics include time management, goal setting, emotional health, decision-making, and maintaining balance in spiritual, personal, and ministry life.

## **SPT201 – Believer’s Authority**

This course examines the biblical foundation of the believer’s authority in Christ. Students will learn how to exercise spiritual authority, apply Scripture in overcoming opposition, and walk in victory through their identity in Christ.

## **SPT202 – Battle for the Body**

This course addresses biblical principles related to physical stewardship, purity, and holistic health. Emphasis is placed on honoring God through the body, overcoming destructive habits, and maintaining physical and spiritual discipline.

## **LED201–202 – Leadership 1–2**

This two-part course develops foundational and intermediate leadership principles for effective ministry. Students will explore servant leadership, character development, team dynamics, decision-making, and leading with vision and integrity.

## **LED204 – Stewardship**

This course teaches biblical stewardship of time, finances, resources, and spiritual gifts. Students will learn principles of accountability, generosity, and faithful management in alignment with Kingdom values.

## **LIF204 – Pathway to Your Destiny**

This course helps students discover and pursue their God-given purpose. Through biblical teaching and practical application, students will identify calling, develop vision, and take intentional steps toward fulfilling their destiny in Christ.

## **MIS201 – Strategies for Spiritual Harvest**

This course equips students with biblical and practical strategies for evangelism and Kingdom expansion. Emphasis is placed on outreach methods, spiritual readiness, and mobilizing believers for effective harvest in diverse contexts.

## **EVG202 –Ministry to Muslims**

This course equips students with a respectful, informed, and biblically grounded approach to engaging with Muslims and Islamic belief systems. Students will gain a foundational understanding of Islamic theology, core beliefs, and cultural contexts, while learning how to communicate the Gospel of Jesus Christ with clarity, wisdom, and compassion.

Emphasis is placed on relational engagement, apologetic awareness, and Spirit-led witness, with a focus on honoring individuals while confidently presenting the message of Christ. The course also addresses common misconceptions, bridges points of dialogue, and equips students to minister effectively within diverse cultural and interfaith settings.

## **THEO201 – World Religions**

This course provides an overview of major world religions and belief systems. Students will examine key doctrines, practices, and cultural influences while developing a biblical framework for understanding and engaging other faiths.

## **COM301 – Speech Communication and Homiletics**

This course develops effective communication skills for ministry, with an emphasis on public speaking and biblical preaching. Students will learn principles of sermon preparation, message structure, delivery techniques, and communicating Scripture with clarity and impact.

## **LED301 – Biblical Management**

This course explores principles of leadership and administration based on biblical models. Students will examine organizational structure, team leadership, decision-making, and stewardship within ministry and Kingdom-focused environments.

## **LED302 – Social Roles & Relationships**

This course examines biblical principles governing relationships in family, church, and society. Topics include communication, conflict resolution, roles and responsibilities, and building healthy, Christ-centered relationships.

## **CNS301 – Ministering to Personal Needs**

This course equips students to effectively minister to individuals facing personal, emotional, and spiritual challenges. Emphasis is placed on compassion, discernment, prayer ministry, and applying biblical solutions to real-life situations.

## **MIN301 – Pastoral Ministry: Practicum**

This supervised practicum provides hands-on ministry experience in a local church or ministry setting. Students will apply classroom learning in pastoral care, leadership, and ministry functions under guided oversight and evaluation.

## **CNS302 – Bible Counseling**

This course introduces foundational principles of biblical counseling. Students will learn how to provide Scripture-based guidance, address personal and spiritual issues, and support individuals toward healing and growth.

## **BTH301 – Acts of the Apostles**

This course provides an in-depth study of the Book of Acts, focusing on the early Church's formation, apostolic ministry, and the work of the Holy Spirit. Students will examine principles for Church growth, mission, and Kingdom expansion.

## **MIN302 – Deliverance – Possess the Land**

This course examines the biblical foundation and practice of deliverance ministry. Students will learn principles of spiritual authority, identifying areas of bondage, and applying Scripture in bringing freedom and restoration.

## **PRY301 – Intercessory Prayer**

This course develops a strong foundation in intercessory prayer as a strategic ministry. Students will learn principles of standing in the gap, spiritual discernment, and partnering with God in advancing His purposes through prayer.

## **EVG301 – Evangelism**

This course equips students with biblical understanding and practical methods for sharing the Gospel. Emphasis is placed on personal evangelism, outreach strategies, and mobilizing believers for effective Kingdom impact.

## **PRAC101, PRAC201, PRAC301 - Student Practicum**

The student practicum is a required component of the Institute whereby each student must enroll in a ministry department of their local church. The department head will need to complete a report of the student's involvement and progress. The practicum is required for each semester of study.

## **PRACTICAL MINISTRY INTERNSHIP**

Students are required to participate in practical ministry internships within their local churches or approved ministries. Internships allow students to apply biblical principles in real ministry environments under supervision.

Students receive **academic credit** for approved ministry participation.

## **PROGRAM STRUCTURE DETAILS**

### **Certificate of Practical Theology (40 Credits total)**

The Certificate program provides foundational biblical education designed to strengthen the student's understanding of Scripture and Christian doctrine. The program combines classroom instruction with introductory ministry practice.

### **Diploma of Practical Theology (80 Credits total)**

The Diploma program builds upon the Certificate program by providing deeper theological instruction and leadership development for ministry participation.

Students complete additional courses in leadership, biblical interpretation, and ministry development.

### **Bachelor of Practical Theology (120 Credits total)**

The Bachelor's program is designed for students preparing for significant ministry leadership roles. The program combines academic study, ministry application, leadership development, and practical ministry training.

The Bachelor program includes three academic years of study.

### **Master of Practical Theology (36 Credits)**

The Master's program is designed for students who have completed a Bachelor's Degree and desire advanced ministry preparation.

Students develop deeper theological insight and ministry leadership skills while completing advanced coursework and a thesis project.

### **Master's Thesis**

Students must complete a major research project or thesis demonstrating advanced theological understanding and ministry application.

### **Doctor of Theology (40 Credits)**

The Doctor of Theology program provides the highest level of theological study offered by the institution.

Students complete advanced research and write a doctoral dissertation focusing on ministry leadership, theology, or Christian practice.

## **PRACTICAL MINISTRY PROGRAM**

All students are required to participate in practical ministry within their local church or approved ministry organization.

The Practical Ministry Program provides supervised ministry experience and allows students to apply classroom knowledge in real ministry contexts.

Students receive academic credit for approved ministry participation each term.
